Block Captains – Martha Gamez

- Martha could not make the meeting
- Don provided some detail on potential changes that would enhance communication with the members of the HOA

Compliance Committee – Elizabeth Allard

- Committee is working on a few compliance issues
- Ms. Allard is walking the neighborhood looking for any issues
- Discussion regarding the filing of a complaint if the person filing the complaint that it is "public knowledge" – State law notes that the information is public.
- If someone wants to make a complaint, start by reviewing the CC&R's regarding the issue
- Short discussion on temporary issues (for example: storage during a construction project)

Grounds and Landscaping - Phil Pitts, acting chair

- Felix Landscaping and crew are really good to work with as they are flexible and responsive
- Short discussion on cutting a tree vs trimming a tree. Trees will be trimmed before it is cut down (see CC&R's)
- Discussion on the herbicide that was recently placed on some of the common areas of the HOA. Herbicide is used to get rid of weeds, keep wanted plants and reduce the time/expense of weed waking vs trimming during the summer months.

New Business – Roads

- Chip seal presenter was not available today
- Road committee has recommended two options: Chip Seal and total Replacement
- Roads are 30 plus years old and in poor condition. Average lifespan of a road in 25-30 years
- \$400K for Chip Seal and \$1.2 million for total replacement (approx. costs)

- Timeline for Chip Seal (assuming the HOA members approve an assessment for the work) would be to make needed repairs to certain needed areas of the roadway in 2025. Then the Chip Seal would take place sometime in 2026.
- Tom Kane brought up the need to take care of the roads now and asked about the current funds. This transitioned to a discussion of the 2025 dues increase (additional funds to be put towards the road fund) and potentially removing the termite service as a way to add additions funds (~\$12,000) to the road fund. As the 2025 budget has been approved, the only way that this could be changed is if there was a motion to reopen the budget. This motion was made seconded and approve.

Budget reopened:

- Motion was made to keep the termite service in the current budget as a service to all members of the HOA. M/S/P
- A good back and forth discussion surrounding the reasons for and against keeping the termite service ensued.
- The motion was called for and a hand vote by those in the meeting was made.
- The motion to Keep the service passed by a clear majority of the members in attendance
